The total charge for this training course is **\$495.00** Students who fail to appear or cancel their scheduled driving lesson without a twenty-four (24) hour notice will be charged **an additional \$25 per one** (1) hour make up lesson. Use of the school's vehicle and instructor for the license examination (optional) shall be a fee of \$150.00.
