The total charge for this training course is **\$575.00**. Students who fail to appear or cancel less than twenty-four hours in advance of driving appointments will be charged an additional **\$25.00** per one hour makeup lesson. Use of the school's vehicle and instructor are available (optional) for license examination for a fee of **\$150.00**.
